We, the undersigned organizations and individuals in the United States and Colombia, ask that you co-sponsor H. Res. 1224, which recognizes and honors the important work that Colombia's Constitutional Court has done on behalf of Colombia's internally displaced persons, in particular Afro-Colombians, indigenous communities, and women, who are disproportionately affected by this widespread humanitarian problem. The resolution which is led by Representative Hank Johnson (GA), calls on the Government of Colombia to fully implement the Constitutional Court's orders concerning these displaced populations, urges the United States to work with Colombian authorities to ensure that the orders of the Colombian Constitutional Court are fully implemented and affirms that Colombia's human rights record will continue to be relevant as Congress deliberates relations between Colombia and the United States. Colombia's internal displacement crisis, affecting over 4 million civilians with 280,000 newly displaced in 2009 alone, disproportionately affects Afrodescendants, indigenous communities and women. It is an invisible tragedy in our hemisphere that merits more attention. While Colombia contains some of the most advanced norms in the world for addressing the problem of internal displacement, the rights enshrined in these norms remain largely on paper and are far from being applied. This gap between the norms and the reality faced by Colombia's internally displaced population led Colombia's Constitutional Court to pronounce in April 2004 that the situation of protection of the rights of internally displaced persons (IDPs) in the country was unconstitutional because the state had not guaranteed a wide range of rights, including the most basic human rights to political, economic and cultural rights for its internally displaced citizens. In January 2009, the Court issued orders 004 and 005, which addressed the specific, deteriorating situation faced by Afro-Colombian and indigenous IDPs. The Court ordered the authorities to develop a differentiated strategy for ethnic populations affected by internal displacement and generate emergency action plans for the 34 indigenous groups in need of urgent attention and 72 Afro-Colombian areas at high risk of displacement. In 2008, the Court also issued order 092 on IDP women that urged the government to enact a series of measures to prevent the disproportionate impact of armed conflict and displacement on women. These include creating thirteen programs to fill the existing gaps in public policy for the assistance of displaced persons from a gender perspective so they address the "gender risks" associated with armed conflict.

These over 4 million persons in situation of displacement are men, women and children whose lives were devastated due to the internal armed conflict, violence, and human rights violations, as well as in some cases, the impact of aerial fumigation. They include people like Jose*, an Afro-Colombian displaced from Cauca who fled his home due to combat between the Colombian military and the FARC guerillas, and who is now in Cali organizing other Afro-Colombians so that collectively they can figure out how to feed their families. Jose, like most

internally displaced, lives in absolute poverty in the district of Agua Blanca, without enough food, proper sanitation, electricity or the possibility of gainful employment. Many like Jose are not only faced with the trauma of witnessing their relatives killed at the hands of illegal armed groups but are also having to survive amongst the drug traffickers and violent illegal armed groups situated in the shantytowns who wish to forcibly recruit their children into their ranks. Colombia has over fifty Afro-Colombian internally displaced groups like Jose's who continue to organize their communities with hope despite their circumstances, trying to regain their rights. It is these leaders to whom the Constitutional Court listened when it developed order 005.

Currently many indigenous communities' human rights and collective land rights are violated by all parties to the conflict. They experience both a general lack of state attention and violence, in part due to the imposition of large scale and extractive development projects without their previous consent. This grave situation led Colombia's Constitutional Court to issue Order 004, which states that 34 indigenous groupings are in danger of physically and culturally becoming extinct unless the government implements a series of immediate protection measures to rectify this situation. The National Indigenous Congress of Colombia reports that 32 indigenous groups currently have a population of less than 500 members. Of these groups, 18 have less than 200 inhabitants and 10 less than a hundred. Internal displacement is one of the central factors leading to the near- cultural and physical extinction of these groups.

It is our belief, as concerned individuals and members of diverse organizations in the U.S. and Colombia, that Colombia's rich cultural diversity must be protected, and that all its citizens' rights to a dignified life must be respected. It would be helpful if the U.S. Congress would demonstrate support for the efforts of a Colombian institution, the Constitutional Court, which is fighting for the rights of its citizens and thus strengthening the rule of law and democracy in Colombia. For these reasons, we strongly recommend that you co-sponsor H. Res. 1224, which will help bring attention to the important work done by Colombia's Constitutional Court and help implement these historic court orders.

Thank you very much for your attention to these important matters. We hope that we can count on your continued support for the promotion of the human rights of the internally displaced in Colombia.
